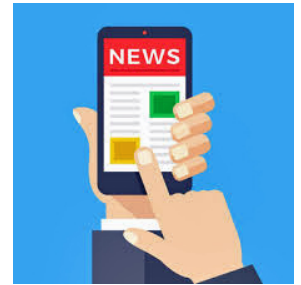

### Ex Libris Association Position Statement on Alberta Bill 28

26 April 2026

The Ex Libris Association has grave concerns about the content and implications of the Alberta Government's Bill 28.

The Ex Libris Association (ELA) is a national organization whose more than 200 members are chiefly retired information professionals, many with deep experience in and knowledge of the public library sector. We believe that the basic premises informing the reasons for this bill to be unfounded and fundamentally false.

We affirm the position of the Library Association of Alberta (LAA) in that "public libraries in Alberta do not collect or distribute illegal, obscene, or pornographic materials. Collections are developed by trained professionals using established policies, industry standards, and community-informed processes. We intentionally and thoughtfully consider age appropriateness in everything we do - from materials we select, to how we support families, to how we design welcoming spaces for children and youth."

We are deeply concerned about the government overreach in this bill that allows government inspectors and officials to overrule the local authority of library directors, library boards and local governments to determine what is appropriate for their communities in regard to library materials, processes, and policies. Such measures would undermine a trusted system that Albertan library users rely on and value.

A further concern, in the words of Ron Sheppard, Director of the Parkland Regional Library System, is that Bill 28 will "undermine access to information ....and the privacy of Albertans." And it would "place library workers in gatekeeping roles that don't reflect how public libraries operate" in the 21st Century.

A recent survey of Albertans found that 82% of Albertans trust their local libraries to make appropriate decisions about what materials are available in their collections, while 69% believe that decisions about library materials should be left to local trained library staff.

The Ex Libris Association stands with the Coalition of Alberta Public Libraries and the Library

Association of Alberta in asking the Government to reflect the trust of its constituents in how Alberta's public libraries are managed.

We strongly urge the withdrawal of the changes to the Libraries Act proposed in Bill 28.

## **Ex Libris Statement on the Elimination of Librarians in Correctional Services Canada Federal Penitentiaries, April 14, 2026**

The Ex Libris Association of Canada is deeply concerned about the decision by Correctional Service Canada (CSC) to eliminate all librarian positions in federal penitentiaries across Canada. Coupled with its intention to end funding for the CEGEP education program serving incarcerated people in Quebec's federal institutions, this represents a sweeping and regressive dismantling of rehabilitative infrastructure within our prison system.

The Ex Libris Association's over 200 members are retired librarians, archivists and information professionals. We have decades of experience offering library and information services to community members, students and faculty at all educational levels and government libraries. We are clear that a prison library without a librarian is not a fully functioning library.

CSC librarians are trained educators and information specialists who curate collections, protect equitable access, support legal research and literacy, deliver programming, and ensure that the most marginalized individuals in CSC's custody can exercise their rights and pursue personal growth. There are at least 31 CSC librarians employed across 38 unique federal prison libraries who hold vital institutional knowledge — knowledge of security protocols, inmate learning needs, culturally appropriate collections, and trauma-informed service — that cannot simply be "absorbed" or replaced without consequence.

CSC's own mandate under the Corrections and Conditional Release Act is to contribute to public safety by assisting offenders in becoming law-abiding citizens. We firmly believe that access to education, information, and literacy is central to that mandate.

Rule 64 of the United Nations Nelson Mandela Rules (United Nations Standard Minimum Rules for the Treatment of Prisoners) is explicit: "Every prison shall have a library for the use of all categories of prisoners, adequately stocked with both recreational and instructional books, and prisoners shall be encouraged to make full use of it." These commitments require professional oversight and sustained investment.

These librarians are among the lowest-paid professionals in the federal system. The savings will be marginal, the damage - to rehabilitation, to institutional stability, to legal literacy, to mental health, and ultimately to public safety - will be profound.

This is not merely a budgetary adjustment. It is a policy choice that disproportionately harms those already marginalized and contradicts Canada's stated commitment to evidence-based corrections and human rights leadership.

Ex Libris joins with Book Clubs for Inmates to urge The Honourable Gary Anandasangaree, Minister of

Public Safety to direct the Commissioner to immediately undertake a genuine and substantive consultation with frontline professionals in education, social programs, and security across the country to identify alternative, responsible savings that meet budgetary mandates without dismantling foundational rehabilitative services.

We therefore call on the Minister of Public Safety, to:

- Immediately suspend the elimination of all librarian positions in federal institutions;
- Reverse the termination of the CEGEP education program in Quebec federal prisons; and
- Publicly clarify how CSC intends to uphold its statutory and human rights obligations with respect to access to education and information by May 1, 2026.

Public safety is not strengthened by shrinking the pathways to literacy, learning, and lawful reintegration. It is strengthened by investing in them.

We hope that those who suffered injuries will recover completely and resume their normal lives. Our thoughts are with you.

As librarians and information specialists, we have always worked to ensure the personal security of our patrons while providing them with the resources they need. To the best of our ability, we will strive to ensure that such a tragedy does not occur in future. While many of us are retired, we remain influential in our profession. We will do our best to make sure that everyone is safe in our libraries as well as our communities.

## **The W.K. Lamb Award presented at Ontario Library Association, January 29, 2026**

The Ex Libris Association is pleased to announce that the Kingston Frontenac Public Library received the W. K. Lamb 2025 award for their "Older Adults Hub" operating out of the library's Rideau Heights Branch located in a low-income neighbourhood with limited services. ELA President David Harvie and W. Kaye Lamb Committee member Donna Burton presented the Award to KFPL Chief Librarian and CEO Laura Carter at the OLA Library Awards Gala in Toronto on January 29, 2026.

The Older Adults Hub was developed in partnership with Kingston Community Health Centres (KCHC) to provide an opportunity for all to be a part of their community in a positive way. A key part includes Monday morning Older Adults Day program that includes KCHC-facilitated Seniors Strength, Fitness & Balance Maintenance Exercise Group, a café for chatting, and a Super Seniors Speaker Series alongside the Library-facilitated Board Game Café, Monthly Book Club, Tech Tutor sessions and a mobile library that brings lending collections into the program space. Library staff reported successes beyond the program's growth as seniors started to gain confidence and form relationships with each other and the program facilitators. Staff commented that the participants had found real friendships in the group. The 'Hub' model has provided multiple accessible programs that offer a variety of fun and free activities where they can meet with their neighbors. We strongly believe that it can be replicated in other libraries and community centres across the City and potentially across Ontario.

The library will receive \$500, the W.K. Lamb Award plaque/certificate and an honorary Ex Libris Association membership.

As in recent years, when the awards notice resulted in a wide and varied response, the ELA Committee has recommended an Honourable Mention nominee. In keeping with this previous action the Edmonton Public Library be acknowledged for their inter-generational program, "Together We Grow."

The Edmonton Public Library's Together We Grow program expands the reach of the library's services to underserved communities, reaching seniors who cannot visit the library due to mobility, memory, or other health issues while nurturing positive relationships between generations by bringing early literacy programming into retirement residences. This program provides engaging activities for seniors, especially those with memory care needs, and gives young children and their parents a chance to connect with another generation. By fostering empathy and understanding between age groups, Together We Grow seeks to combat senior's social isolation and to help older adults find joy in interacting with the youngest members of our community, contributing to a more inclusive and connected community.

The Edmonton library will receive \$100, an honourable mention certificate and honorary membership in the Ex Libris Association.

The selection process was difficult because all the submissions were worthy efforts to further the cause of service to seniors.

## **ELA requests the Government to acquire the 1670 Royal Charter for the Hudson's Bay Co., May 25, 2025**

ELA has sent a letter from its Advocacy Committee on May 25, 2025 to Steven Guilbeault, Minister of Canadian Culture and Identity, requesting that the 1670 charter for the the Hudson's Bay Company be kept in Canada at Library and Archives Canada. This charter is a vital historical document that should be accessible to all Canadians: "The acquisition of this Charter would align perfectly with the mandate of Library and Archives Canada to preserve and make accessible the documentary heritage of our nation. Furthermore, it would demonstrate the government's commitment to protecting irreplaceable cultural treasures for future generations of Canadians." ELA is joining its voice with other library, archival and historical associations in urging the Ministry to acquire this document and keep it in Canada where it will accessible to Canadian researchers.

## **Underfunding of Ontario College and University Libraries, April 2025**

In April 2025, the President of ELA, David Harvey, forwarded a letter to the Ontario Minister of Colleges, Universities, Research Excellence and Security about the Association's concerns regarding the underfunding of colleges and universities, specifically libraries. ELA maintains that the provincial government must recognize the fundamental importance of colleges and universities and the financial problems threatening these institutions. Increased government investment can assist post-secondary institutions to meet the economic challenges of today and provide a better future for the Ontario graduates of tomorrow. ELA strongly urged the government to provide (1) an emergency infusion of \$1.4 billion into college and college libraries; and (2) an additional \$1.34 billion annually to bring Ontario up to the national average for per-student funding.

## **Guy Robertson outlines Disaster Planning for Libraries in ELA webinar, June 18, 2024**

Libraries have to consider many issues for disaster plans to be successful. Guy Robertson is a senior instructor based in Vancouver at Langara College, where he teaches library history, reference and readers' advisory services, and records management. He works as a consultant to organizations across North America. Guy's 45-minute webinar covers a broad range of risks involved with future planning for natural disasters, human-caused problems, technological accidents, security breaches and threats, as well as organizational difficulties. His survey highlights the need for planning to mitigate risks and ensure staff preparedness in the event an unexpected threat should arise.
